## CERTIFICATE OF WATER RIGHT

This Is to Certify, That VIRGIL W. NELSON

of Rt. 1 Box 238, Eagle Creek , State of Oregon, 97022 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells

a tributary of Clackanas River for the purpose of irrigation of 32.1 acres and supplemental irrigation of 14.2 acres

under Permit No. G-4011 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 29, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.24 cubic foot per second, being 0.07 c.f.s. from Well No. 1 and 0.17 c.f.s. from Well No. 2

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE's SE's, Section 29, T. 2 S., R. 4 E., W. M., Well No. 1-1950 feet North and 560 feet West; Well No. 2-2230 feet North and 60 feet West, both from the SE Corner of Section 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
