CERTIFICATE OF WATER RIGHT

This Is to Certify, That **AGNES E. JENSEN**

of **McKinley Route, Box 49, Myrtle Point**, State of Oregon, **97458**, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a spring and North Fork Coquille River

a tributary of **Coquille River** for the purpose of domestic use for one family and irrigation of 10.0 acres

under Permit No. **35743** and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **November 10, 1970**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.13 cubic foot per second, being 0.005 c.f.s. for domestic use from spring and 0.125 c.f.s. for irrigation from river.**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NW $\frac{1}{4}$, NE $\frac{1}{4}$ & Lot 2 (SW $\frac{1}{4}$, NE $\frac{1}{4}$), Section 23, T. 28 S., R. 12 W., W. M.; Spring - 3570 feet East; River - 1640 feet South and 3390 feet East, both from the NW Corner, Section 24.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,**

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**Domestic Use and 1.0 acre NW $\frac{1}{4}$, NE $\frac{1}{4}$
7.8 acres Lot 2 (SW $\frac{1}{4}$, NE $\frac{1}{4}$)
1.2 acres Lot 1 (SE $\frac{1}{4}$, NE $\frac{1}{4}$)
Section 23
T. 28 S., R. 12 W., W. M.**

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
