that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1½ acre feet per acre in any 30-day period prior to June 1st, 1 acre foot per acre in any 30-day period after June 1st, of each year, or 3 acre feet per acre during any season, diverted at a rate not to exceed one-twentieth of a cubic foot per second per acre:

The point of diversion is located in the NE₄ SW₄, and NW₄ SE₄, Section 31, T. 18 S., R. 38 E., W. M., South 38 degrees 12 minutes East 3782 feet and South 47 degrees 50 minutes East 5391 feet both from the NE Corner, Section 36.
