CERTIFICATE OF WATER RIGHT

This Is to Certify, That

GEORGE KUSCHNICK

of Rt. 1, Box 184, Gervais , State of Oregon, 97026 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Pudding River for the purpose of irrigation of 43.6 acres and supplemental irrigation of 58.9 acres

under Permit No.G-4243 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 19, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.28 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWs SWs, as projected within Coonse DLC 56, Section 32, T. 5 S., R. 1 W., W. M., 1400 feet South and 1240 feet West from the NE Corner, Felix Coonse DLC 56.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 24 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
