CERTIFICATE OF WATER RIGHT

This Is to Certify, That S. G. VISTICA

of Rt. 2 Box 280, Woodburn, State of Oregon, 97071, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of an unnamed stream and Zollner Creek

a tributary of Pudding River for the purpose of irrigation of 36.9 acres

under Permit No. 32292 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 12, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.46 cubic foot per second, being 0.39 c.f.s. from unnamed stream and 0.07 c.f.s. from Zollner Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$; SE $\frac{1}{4}$ NE $\frac{1}{4}$; Section 33, T. 5 S., R. 1 W., W. M., Unnamed stream-690 feet South and 10 feet West; Zollner Creek-2450 feet South and 2100 feet East; both from the N $\frac{1}{2}$ Corner, Section 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre foot per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Zollner Creek
5.9 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$
Section 33
T. 5 S., R. 1 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
