CERTIFICATE OF WATER RIGHT

This Is to Certify, That **BURLINGAME LAND & LIVESTOCK, INC.**

of **Box 60, Touchet**, State of **Washington, 99360**, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of **two wells**

a tributary of **Dry Creek** for the purpose of irrigation of **81.9 acres and supplemental irrigation of 230.4 acres**

under Permit No. **C-3882** and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **November 6, 1967**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **1.43 cubic feet per second, being 0.83 c.f.s. from Well No. 1 and 0.60 c.f.s. from Well No. 2**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SE 1/4, Section 29, NE 1/4, Section 32, T. 6 N., R. 35 E., W. M., #1 - 320 feet North and 50 feet West, #2 - 930 feet South and 40 feet West, both from the SE Corner of Section 29.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **3 acre feet per acre for each acre irrigated during the irrigation season of each year.**

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
