## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** KISTNER FARMS, INC.

of Rt. 2, Box 279, Forest Grove, State of Oregon, 97116, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Park Creek and Cedar Canyon Creek

a tributary of Dairy Creek for the purpose of the irrigation of 71.3 acres

under Permit No. 1573 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 2, 1913 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.89 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 34, T. 2 N., R. 4 W., W. M., 2530 feet South and 1670 feet West from the NE Corner, Section 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

12.8 acres NW $\frac{1}{4}$  NE $\frac{1}{4}$   
 28.4 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$   
 12.3 acres SE $\frac{1}{4}$  NE $\frac{1}{4}$

 10.0 acres NW $\frac{1}{4}$  SE $\frac{1}{4}$

 0.2 acre SW $\frac{1}{4}$  NW $\frac{1}{4}$

This certificate is issued to confirm a change in place of use and point of diversion approved June 2, 1967, and together with Special Order Volume 16, Page 103 supersedes certificate of water right 810.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
