CERTIFICATE OF WATER RIGHT

a tributary of Tualatin River irrigation of 89.5 acres

for the purpose of

under Permit No. 20255 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 13, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.1 cubic feet per second

or its equivalent in case of rotation; measured at the point of diversion from the stream. The point of diversion is located in the NEW NEW, as projected within Wm. Bell DLC 57, Section 20, T. 1 N., R. 4 W., W. M., 920 feet South and 1850 feet East from the SW Corner of the S. Shepherd DLC 62; NEW NEW, as projected within Wm. Bell DLC 57, Section 21, T. 1 N., R. 4 W., W. M., 1060 feet South and 3000 feet East from the SW Corner of the S. Shepherd DLC 62.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
