## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**

SAMUEL GOVER ESTATE, MATTIE GOVER, CARSON GOVER, VINA GOVER AND WOODY GOVER

of New Bridge, State of Oregon, 97870, has  
a right to the use of the waters of Eagle Creek,

a tributary of Powder River for the purpose of  
irrigation of 161.0 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at page 291; that the priority of the right thereby confirmed dates from 1879 for 71.0 acres; 1885 for 80.0 acres; and 1888 for 10.0 acres

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth of one cubic foot per second per acre, and shall be subject to all other conditions and limitations contained in said decree.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
