## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

LOUIS PALLIN

of Route 2, Box 1295, Bandon , State of Oregon, 97411 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Spring Creek

a tributary of Coquille River for the purpose of irrigation of 5.54 acres, supplemental irrigation of 6.0 acres, frost control, and cranberry harvesting of 11.54 acres.

under Permit No. 33632 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 29, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic foot per second, being 0.075 c.f.s. for irrigation, 0.28 c.f.s. for frost control, and 0.28 c.f.s. for cranberry harvesting.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEX NEX, Section 20, T. 28 S., R. 14 W., W. M., 800 feet South and 1700 feet East from the Nx Corner, Section 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
