## CERTIFICATE OF WATER RIGHT

, State of Oregon, 97302 3357 Agusta International, Salem , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells

a tributary of Willamette River irrigation of 64.2 acres

for the purpose of

under Permit No. G-4582 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 7, 1969

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.81 cubic foot per second, being 0.43 c.f.s. from Well No. 5 and 0.38 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the No. 2-Lot 11 (SW4 SW4), Section 21; No. 3-NE4 NE4, Section 29, T. 15 S., R. 4 W., W. M., No. 2-530 feet South and 690 feet West; No. 3-2210 feet South and 1670 feet West; both from the NE Corner, Lot 11 (SW4 SW4), Section 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 21/2 acre feet per acre for each acre irrigated during the irrigation season of each year; and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> Well No. 22.7 acres Lot 11 (SW4 SW4) Section 21 7.3 acres NW4 NW4 Section 28 T. 15 S., R. 4 W., W. M.

Well No. 3 21.3 acres NW& NW2 1.4 acres SW4 NW4 Section 28 10.9 acres NEW NEW 0.6 acre SE% NE% Section 29 T. 15 S., R. 4 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies entablished by the Water Policy Review Board.
