CERTIFICATE OF WATER RIGHT

of 315 N. Phoenix Road, Medford , State of Oregon, 97501 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Hog Creek, N. unnamed gulch, and S. unnamed gulch

a tributary of Rogue River for the purpose of irrigation of 1.7 acres and supplemental irrigation of 13.0 acres

under Permit No. 30420 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 3, 1965

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.18 cubic foot per second, being 0.11 c.f.s. from Hog Creek, 0.06 c.f.s. from N. unnamed gulch, and 0.01 c.f.s. from S. unnamed gulch

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the #1-NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 20; #2-Lot 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$); #3-SW $\frac{1}{4}$ NE $\frac{1}{4}$; #4-Lot 3 (NE $\frac{1}{4}$ SW $\frac{1}{4}$), Section 29, T. 35 S., R. 1 W., W. M., #1-1340 feet North and 1540 feet East, #2-890 feet South, #3-1640 feet South and 620 feet East, #4-3130 feet South and 50 feet West, all from the NW $\frac{1}{4}$ Corner of Section 29.The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighthieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{4}$ acre foot per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
