CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ADRIAN L. AND KENT D. WILCOX

of 311 Vaughn Lane, Lebanon, State of Oregon, 97355, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Hamilton Creek

a tributary of South Santiam River
irrigation of 41.7 acres

for the purpose of

under Permit No. 31551 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 2, 1966
that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.52 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 8 (SE $\frac{1}{4}$ SE $\frac{1}{4}$), Section 22, T. 12 S., R. 1 W., W. M., 1660 feet North and 4520 feet West from the NE Corner, Hardman DLC 46.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.3 acre Lot 4 (NE $\frac{1}{4}$ SE $\frac{1}{4}$)
12.6 acres Lot 8 (SE $\frac{1}{4}$ SE $\frac{1}{4}$)
Section 22
5.6 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
6.8 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$
Both as projected within Bellinger DLC 47
0.4 acre Lot 3 (SW $\frac{1}{4}$ SW $\frac{1}{4}$)
2.0 acres Lot 4 (SE $\frac{1}{4}$ SW $\frac{1}{4}$)
14.0 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$
As projected within Bellinger DLC 47
Section 23
T. 12 S., R. 1 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
