under Permit No. G-2953 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 19, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.4 cubic feet per second, being 1.7 c.f.s. from each well

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW Well: Lot 4 (SW: SW:), Section 30, T. 4 N., R. 27 E., W. M.; 3920 feet South and 1350 feet East from the NW Corner, Section 30; SE Well: NW: SE's, Section 30, T. 4 N., R. 27 E., W. M.; 3830 feet South and 4160 feet East from the NW Corner, Section 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
