## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** BAUNE FARMS, INC.

of Rt. 3, Box 20-A, Milton-Freewater, State of Oregon, 97862, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Dry Creek

a tributary of Pine Creek for the purpose of irrigation of 256.0 acres

under Permit No. 29083 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 21, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.0 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 4, T. 5 N., R. 35 E., W. M., 830 feet South and 3320 feet East from the Center, Section 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~one-sixtieth~~ of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of a special order dated February 22, 1963 and recorded on page 329, Volume 12, Special Order Record, and by reference made a part hereof,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
