CERTIFICATE OF WATER RIGHT

This Is to Certify, That

HAROLD BUCKNER

of Terrebonne , State of Oregon, 97760 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Lone Pine Creek and Buckner Reservoir constructed under Application No. R-38344 Permit No. R-3248

a tributary of Crooked River supplemental irrigation of 216.1 acres

for the purpose of

under Permit No. 28702 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 7, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.0 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 SE4, Section 33, T. 13 S., k. 14 E., W. M., 200 feet North and 50 feet West from the SE Corner, Section 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortleth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-3248.

conform to such reasonable rotation system as may be ordered by the proper state officer.
