## CERTIFICATE OF WATER RIGHT

of Rt. 1, Box 636, Dundee , State of Oregon, 97115 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willametee River & Yamhill River

a tributary of Columbia River irrigation of 100.5 acres

for the purpose of

under Permit No. 37636 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 27, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.25 cubic feet per second, being 0.43 c.f.s. from Willamette River and 0.82 c.f.s. from Yamhill River

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Willamette River: Lot 2 (NWx SEX), Section 12; Yamhill River: SWx, as projected within Crawford DLC 71, Section 12 & NEX NWX, as projected within Crawford DLC 71, Section 13, T. 4 S., R. 3 W., W. M., 1620 feet North and 3820 feet East, 480 feet North and 30 feet Fast, 580 feet South and 2040 feet East, all from the SW Corner, Section 12

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
