under Permit No. G-4501 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 3. 1969

that the amount of wall to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.07 cubic foot per second, being 0.02 c.f.s. from the well and 0.05 c.f.s. from the sump well

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SW4, Section 30, T. 5 S., R. 1 E., W. M., Well-200 feet North and 660 feet East; Sump Well-220 feet North and 880 feet East, both from the SW Corner, Section 30

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-zightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year; and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others,
