CERTIFICATE OF WATER RIGHT

This Is to Certify, That MR. OR MRS. D. G. MILLER

of 1590 Thompson Creek Rd., Applegate, State of Oregon, 97530, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of 4 wells

a tributary of Thompson Creek for the purpose of supplemental irrigation of 19.1 acres

under Permit No. G-5021 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 12, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.24 cubic foot per second, being 0.10 c.f.s. from Well No. 1, 0.06 c.f.s. from Well No. 2, 0.03 c.f.s. from Well No. 3, 0.05 c.f.s. from Well No. 4

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 28, T. 38 S., R. 4 W., W. M., No. 1-130 feet North and 530 feet West, No. 2-40 feet North and 70 feet West, No. 3-90 feet North and 10 feet East, No. 4-240 feet North and 100 feet East, All from the SW Corner, SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 28

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.8 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$

9.0 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$

4.3 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$

Section 28

T. 38 S., R. 4 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
