## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** BURT K. AND OR ALICE R. HANSEN

of 23989 Evans Creek Rd., Central Point, State of Oregon, 97501, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Chatman Creek and East Fork Evans Creek with any deficiency in the available supply from Chatman Creek to be made up by appropriation from Evans Creek \* a tributary of Evans Creek for the purpose of irrigation of 11.6 acres

under Permit No. 34608 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 14, 1969 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.14 cubic foot per second, being 0.11 c.f.s. from Chatman Creek and 0.03 c.f.s. from East Fork Evans Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NE $\frac{1}{4}$ , NE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 33, T. 33 S., R. 2 W., W. M., Chatman Creek-2730 feet North and 3380 feet East, East Fork Evans Creek-2030 feet North and 2220 feet East both from the SW Corner, Section 33

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~one-eighth~~ of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

East Fork Evans Creek  
2.6 acres NE $\frac{1}{4}$  SW $\frac{1}{4}$

Chatman Creek  
3.0 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$   
2.8 acres NE $\frac{1}{4}$  SW $\frac{1}{4}$   
3.2 acres NW $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 33  
T. 33 S., R. 2 W., W. M.

\* provided that the total quantity diverted from both sources shall not exceed 0.14 c.f.s.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
