CERTIFICATE OF WATER RIGHT

This Is to Certify, ThatROBERT D. & SUZANNE H. CHASE

of 11048 Hwy. 238, Jacksonville, State of Oregon, 97530, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Applegate River

a tributary of Rogue River
irrigation of 23.2 acres

for the purpose of

under Permit No. 31914 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 26, 1966 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.29 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 10 (SE $\frac{1}{4}$ SW $\frac{1}{4}$), SW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within La Clair DLC 38, Section 28, T. 38 S., R. 3 W., W. M., No. 1-40 feet North and 1610 feet East from the SW Corner, Section 28; No. 2-330 feet North and 520 feet East from the W $\frac{1}{2}$ Corner, Section 28

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
