CERTIFICATE OF WATER RIGHT

This is to Certify, That **R. LEE STEWART**, of Baker, Oregon, and

of **J. H. STEWART**, State of **Alaska**, has a right to the use of

the waters of **Powder River, tributary of Snake River, and Beaver or Willow Creek, tributary of Powder River,** for the purpose of **the irrigation of 323.5 acres of land**

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for **Baker** County, and the said decree entered of record at Salem, in the Order Record of the **STATE WATER BOARD** of the State of Oregon, in Volume **six** at page 291 ; that the priority of the right thereby confirmed dates from **1869 for 80 acres, 1880 for 42.4 acres, 1892 for 167.9 acres in Tract No. 1; 1869 for 33.2 acres in Tract No. 2;**

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **one-fortieth of one cubic foot per second per acre**, and shall be limited to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract No. 1 from Powder River: 3.6 acres in Northeast quarter of Northeast quarter; 22.4 acres in Southeast quarter of Northeast quarter; 14.8 acres in Northeast quarter of Southeast quarter; 9 acres in Southeast quarter of Southeast quarter of Section Seven; 31.8 acres in Northeast quarter of Northwest quarter; 40 acres in Northwest quarter of Northwest quarter; 40 acres in Southwest quarter of Northwest quarter; 26.3 acres in Southeast quarter of Northwest quarter; 22.4 acres in Northeast quarter of Southwest quarter; 40 acres in Northwest quarter of Southwest quarter; 40 acres in Southwest quarter of Southwest quarter of Section Eight.

Tract No. 2 from Beaver or Willow Creek: 22.7 acres in Northeast quarter of Northwest quarter of Section Seventeen; 10.5 acres in Southeast quarter of Southwest quarter of Section Eight, Township Ten South, Range Forty East of Willamette Meridian, in Baker County, Oregon.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
