CERTIFICATE OF WATER RIGHT

This Is to Certify, That PHILIP A. HAWMAN

of Rt. 1, Box 529, Dundee, State of Oregon, 97115, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Yamhill River

a tributary of Willamette River for the purpose of irrigation of 34.1 acres

under Permit No. 36861 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 19, 1972 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.43 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Alderman DLC 43, Section 9; NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Alderman DLC 43, Section 10, T. 4 S., R. 3 W., W. M., 4530 feet South and 10 feet West, 3530 feet South and 420 feet East, both from the NE Corner, Section 9

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

18.4 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$
 15.2 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$
 Both as projected within Alderman DLC 43
 Section 9
 0.5 acre SW $\frac{1}{4}$ NW $\frac{1}{4}$
 As projected within Alderman DLC 43
 Section 10
 T. 4 S., R. 3 W., W. M.

This certificate describes that portion of the right perfected under the terms of water right permit No. 36861, NOT modified by the provisions of an order of the Water Resources Director entered on July 29, 1977, approving transfer application No. 3540.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
