## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

WILLIAM E. STROWBRIDGE

of 616 Cathline St., Medford , State of Oregon, 97501 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Roque River

a tributary of Pacific Ocean the irrigation of 5.6 acres

for the purpose of

under Permit No. 15664 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

December 16, 1943 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.069 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (NE $\frac{1}{4}$  SE $\frac{1}{4}$ ), Section 16, T. 34 S., R. 1 W., W. M., No. 1-790 feet South and 360 feet West, No. 2-950 feet South and 620 feet West, both from the E $\frac{1}{4}$  Corner, Section 16

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.6 acres Lot 3 (NE½ SE½) Section 16 T. 34 S., R. 1 W., W. M.

This certificate describes that portion of the water right confirmed by prior certificate 19511, as modified under the provisions of an order of the State Engineer entered on August 23, 1961, approving transfer application No. G-53, but NOT modified by the provisions of orders entered on March 30, 1977, approving transfer applications Nos. 2857 and 3601.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
