and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 5, at page 171-2; that the priority of the right thereby confirmed dates from 1889 for Tract No. 2; 1895 for Tract No. 3

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1½ acre feet per acre during any period of 30 days prior to July 31st of each year and thereafter not to exceed 1 acre foot per acre during the entire remainder of the irrigation season; and shall be subject to all other conditions and limitations contained in said decree.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

Tract No. 2, irrigated from Wallowa River: 7.0 acres NW4 NE4, 19.0 acres SW4 NE4, 38.0 acres NE4 NW4, 34.0 acres NW4 NW4, 8.5 acres SW4 NW4, 19.5 acres SE4 NW4, and 12.0 acres NW4 SE4, Section 3, T. 1 S., R. 43 E., W. M., in Wallowa County, Oregon.

Tract No. 3, irrigated from the South Fork of Wallowa River: 2.9 acres NE% SW%, and 2.0 acres NW% SW%, Section 10, T. 1 S., R. 43 E., W. M., in Wallowa County,

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 37398, Volume 29, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Water Resources Director entered on August 18, 1977, approving transfer application No. 3598, and December 13, 1977, approving transfer application No. 3637.

The issuance of this superseding certificate does not confirm the status of the water right in reference to $ORS\ 540.610$.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
