CERTIFICATE OF WATER RIGHT

This Is to Certify, That **ELDON FENDALL**

of Rt. 2, Willamina, State of Oregon, 97396, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willamina Creek

a tributary of South Yamhill River for the purpose of irrigation of 68.5 acres

under Permit No. 26028 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 4, 1959 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.607 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Burford DLC 44, Section 24, T. 5 S., R. 7 W., W. M., 1725 feet North and 1575 feet West from the SE Corner, Section 24

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.2 acres SW $\frac{1}{4}$ NE $\frac{1}{4}$
12.7 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
22.9 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
26.0 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
1.7 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$

All as projected within Burford DLC 44
Section 24

T. 5 S., R. 7 W., W. M.

This certificate describes that portion of the water right confirmed by prior certificate 28293, NOT modified by the provisions of an order entered on January 26, 1977, approving transfer application No. 3347. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
