## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** LOUISE KOESTER

of North Powder, State of Oregon, 97867, has  
a right to the use of the waters of Powder River

a tributary of Snake River for the purpose of  
the irrigation of 164.0 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at page 291; that the priority of the right thereby confirmed dates from 1886 for 72.0 acres in Tract No. 1 and 1907 for 92.0 acres in Tract No. 2

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 of one cubic foot per second per acre; and shall be subject to all other conditions and limitations contained in said decree.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
