CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. A. ALBERTSON & TRAVELERS INSURANCE CO.

of P. O. Box 20, Boise, State of Idaho, 83726, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Snake River

a tributary of Columbia River for the purpose of irrigation of 200.8 acres

under Permit No. 37474 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 2, 1974

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.02 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$), Lot 2 (SE $\frac{1}{4}$ NW $\frac{1}{4}$), Lot 4 (SE $\frac{1}{4}$ SW $\frac{1}{4}$), Section 21, T. 19 S., R. 47 E., W. M., No. 1-1390 feet North and 2120 feet East, No. 2-40 feet North and 2260 feet East, No. 3-1650 feet South and 2310 feet East, all from the W $\frac{1}{2}$ Corner, Section 21

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
