## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** J. M. HAGER

of Heppner, State of Oregon, 97836, has  
a right to the use of the waters of Willow Creek

a tributary of Columbia River for the purpose of  
irrigation of 81.67 acres and domestic use; (irrigation during the irrigation  
season)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for  
Morrow County, and the said decree entered of record at Salem, in the Order Record of  
the WATER RESOURCES DIRECTOR, in Volume 1, at page 73; that the priority of the  
right thereby confirmed dates from 1870 for Tract No. 1 and 1894 for Tract No. 2

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an  
amount actually beneficially used for said purposes, and shall not exceed 1.10 cubic feet per  
second as of date 1870 and 0.26 cubic foot per second as of date 1894.

And said right shall be subject to all other conditions and limitations contained in said decree.  
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of  
use herein described.
