## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** UNION ORCHARD COMPANY

of Union, State of Oregon, 97833, has  
a right to the use of the waters of Catherine Creek

a tributary of Grande Ronde River for the purpose of  
the irrigation of 90 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for  
Union County, and the said decree entered of record at Salem, in the Order Record of  
the WATER RESOURCES DIRECTOR, in Volume 8, at page 1; that the priority of the  
right thereby confirmed dates from 1874

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an  
amount actually beneficially used for said purposes, and shall not exceed Three acre feet per  
acre in any irrigation season, diverted at a rate of not to exceed one-fortieth  
of a cubic foot per second per acre;

The point of diversion is located in the NE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 19, T. 4 S., R. 40 E., W. M.,  
850 feet South and 2870 feet West from the N $\frac{1}{4}$  Corner, Section 20

A description of the place of use under the right, and to which such right is appurtenant, is as  
follows:

10.0 acres SE $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 24  
40.0 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$   
Section 25  
T. 4 S., R. 39 E., W. M.  
10.0 acres SW $\frac{1}{4}$  SW $\frac{1}{4}$   
Section 19  
30.0 acres NW $\frac{1}{4}$  NW $\frac{1}{4}$   
Section 30  
T. 4 S., R. 40 E., W. M.

And said right shall be subject to all other conditions and limitations contained  
in said decree.

This certificate describes that portion of the water right confirmed by the prior  
certificate recorded at page 6609, Volume 7, State Record of Water Right  
Certificates, NOT modified by the provisions of an order of the Water Resources  
Director entered on December 23, 1976, approving transfer application No. 3256.

The issuance of this superseding certificate does not confirm the status of the  
water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree.  
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of  
use herein described.
