CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHARLES & VIVIAN HEADD

of Rt. 3, Box 208, McMinnville, State of Oregon, 97128, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Yamhill River

a tributary of Yamhill River for the purpose of irrigation of 38.4 acres

under Permit No. 36991 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 13, 1972 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.48 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Alexis Miller DLC 64, Section 12, T. 5 S., R. 5 W., W. M., 850 feet South and 180 feet East from the NW Corner, Section 12

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.1 acre NE $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Alexis Miller DLC 64
 13.8 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Richard Miller DLC 65
 2.8 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Richard Miller DLC 65
 9.5 acres SW $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Richard Miller DLC 65
 11.6 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Richard Miller DLC 65
 Section 11

0.6 acre NW $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Alexis Miller DLC 64
 Section 12
 T. 5 S., R. 5 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
