CERTIFICATE OF WATER RIGHT

This Is to Certify, That MEADOWBROOK ORCHARD COMPANY

of Medford, State of Oregon, 97501, has a right to the use of the waters of Wards Creek

a tributary of Rogue River for the purpose of irrigation of 16.1 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at page 1; that the priority of the right thereby confirmed dates from 1904

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.27 cubic foot per second.

The point of diversion is located in the No. 1-SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 14, 250 feet South and 650 feet East from the NW Corner, Section 14; No. 2-NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 14, 40 feet North and 670 feet East from the NW Corner, Section 14; No. 3-SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 14, 40 feet North and 110 feet East from the Center Corner, Section 14; * A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate describes the water right confirmed by the prior certificate recorded at page 16172, Volume 13, State Record of Water Right Certificates, as modified under the provisions of orders of the State Engineer, entered on September 14, 1938, January 29, 1964, December 30, 1963 and January 13, 1965, approving transfer applications Nos. D-13, T-59, G-56 and D-103, and an order entered on December 21, 1966, canceling a portion of said right. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
