CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DAVID W. SIMPSON

of 14922 Ramsey Rd., Central Point, State of Oregon, 97501, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Ramsey Canyon & Simpson Reservoir constructed under Application No. R-42647, Permit No. R-4730 a tributary of Evans Creek for the purpose of irrigation of 16.3 acres and supplemental irrigation of 6.6 acres

under Permit No. 31249 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 16, 1966 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.20 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 5, T. 35 S., R. 2 W., W. M., 1630 feet South and 950 feet East from the NW Corner, Section 5

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighthieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-4730 provided further that the right allowed herein shall be limited to stored water only on the lands described as supplemental,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

 4.4 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
 6.3 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$
 4.0 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
 1.6 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$

 3.8 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$
 2.8 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
