## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** R. C. JEFFERSON

of Route 2, Silverton, State of Oregon, 97381, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Woods Creek

a tributary of Pudding River for the purpose of irrigation of 11.6 acres

under Permit No. 16516 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 13, 1945 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.145 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 10 (NW $\frac{1}{4}$  NE $\frac{1}{4}$ ), Section 23, T. 6 S., R. 2 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

T. 6 S., R. 2 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the N.W. corner of the Donation Land Claim of Asa Saunders in T. 6 S., R. 2 W. of the Willamette Meridian, Marion County, Oregon. Thence East 8.25 chains, along the north line of the Asa Saunders Claim, to the S.E. corner of Lot No. 10 of section 23 in said Township and Range. Thence North 14.12 chains, to the line between sections 14 and 23, and being also the N.E. corner of Lot No. 10. Thence West 20.00 chains, along the line between sections 14 and 23, to the N.W. corner of Lot No. 10. Thence South 14.12 chains, along the west line of Lot No. 10, to a point west of the place of beginning. Thence East 11.75 chains, to the place of beginning and containing 28.24 acres of land, more or less.


This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 16915, Volume 14, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on November 28, 1977.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.*
