## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of Rt. 1, Box 129, Brooks , State of Oregon, 97305 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two unnamed drainage ditches and Pudding River

a tributary of Willamette River irrigation of 95.1 acres

for the purpose of

under Permit No. 20271 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 28, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second, water to be diverted from drainage ditch when available and any deficiency in the available supply in the South drainage ditch to be made up by diversion from the Pudding River, providing that the total \*

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SW4, as projected within Parker DLC 49; NW4 SE4, SW4 SE4, both as projected within Carey DLC 58, Section 5, T. 6 S., R. 1 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. .

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
