of P. O. Box 78, Fairview , State of Oregon, 97024 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a Spring, 2 unnamed streams and reservoir constructed under Permit No. R-5964

a tributary of Arata Creek supplemental irrigation of 56.9 acres

for the purpose of

under Permit No. 36772 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 6, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.27 cubic foot per second, being 0.05 c.f.s. from Spring No. 3, 0.07 c.f.s. from Stream No. 2, and 0.15 c.f.s. from Stream No. 3

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 NW4 & SE4 NW4, both as projected within Molloy DLC 55, Section 34, T. 1 N., R. 3 E., W. M.; Spring No. 3-500 feet South and 700 feet East; Streams-No. 3 - 240 feet South and 1000 feet East; No. 2 - 370 feet South and 1080 feet East; Reservoir-160 feet South and 930 feet East, all from the NW Corner of Molloy DLC 55.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-5964,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.4 acres SW4 NW4
5.4 acres NE4 SW4
25.5 acres NW4 SW4
17.7 acres SW4 SW4
3.9 acres SE4 SW4
All as projected within Molloy DLC 55
Section 34
T. 1 N., R. 3 E., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
