CERTIFICATE OF WATER RIGHT

This Is to Certify, That

JOHN W. KOPPLIN

of Rt. 1, Box 99, Portland , State of Oregon, 97231 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Tualatin River and Hill Creek

a tributary of Willamette River the irrigation of 50.0 acres

for the purpose of

under Permit No. 12373 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 4, 1936

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.63 cubic foot per second measured at the point of diversion from the stream, being 0.56 c.f.s. from Tualatin River and 0.07 c.f.s. from Hill Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, and NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 7, T. 2 S., R. 3 W., W. M., NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 12, T. 2 S., R. 4 W., W. M., all as projected within Hill DLC 42, and NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 36, T. 1 S., R. 4 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. •

A description of the place of use under the right hereby confirmed, and to which such right

is appurtenant, is as follows:
