This Is to Certify, That GAYLORD S. & SARAH C. EGGLESTON

of Route 2, Box 471, Estacada , State of Oregon, 97023 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two springs

a tributary of Clear Creek for the purpose of domestic use for one family, stock, and irrigation of 7.1 acres

under Permit No. 35942 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 13, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.06 cubic foot per second, being 0.01 c.f.s. from Spring No. 1 for domestic use, 0.01 c.f.s. from Spring No. 2 for stock, and 0.02 c.f.s. from Spring No. 2 for irrigation and 0.02 c.f.s. from Spring No. 1 for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 NW4, as projected within Tucker DLC 44, Section 9, T. 4 S., R. 4 E., W. M., Spring No. 1 - 370 feet South and 800 feet East; Spring No. 2 - 470 feet South and 1010 feet East; both from the SW corner of Lot 3 (SW4 NW4) of Section 9.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
