of Route 1, Box 261, Willamina , State of Oregon, 97376 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Yamhill River

a tributary of Yamhill River irrigation 181.5 acres

for the purpose of

under Permit No. 36310 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 25, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.25 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE½ SW½, Section 9, NW½ NE½, as projected within Hussey DLC 45, Section 16, T. 6 S., R. 7 W., W. M., No. 1-2010 feet North and 1380 feet East; No. 2-510 feet South and 3380 feet East; both from the SW Corner of Section 9.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
