## CERTIFICATE OF WATER RIGHT

*This Is to Certify, That*VINEYARD IRRIGATION ASSOCIATION  
CHARLES RULLMAN, JR., PRESIDENT

of 2615 S.E. Vineyard Way, Milwaukie, State of Oregon, 97222, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willamette River

a tributary of Columbia River for the purpose of irrigation of 1.5 acres

under Permit No. 16404 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 9, 1945 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.019 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within S. H. Walker DLC 52, Section 13, T. 2 S., R. 1 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre NE $\frac{1}{4}$  NW $\frac{1}{4}$

0.2 acre NW $\frac{1}{4}$  NW $\frac{1}{4}$

0.3 acre SW $\frac{1}{4}$  NW $\frac{1}{4}$

0.2 acre SE $\frac{1}{4}$  NW $\frac{1}{4}$

All as projected within S. H. Walker DLC 52

T. 2 S., R. 1 E., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

A part of the S. H. Walker DLC 52 in Township 2 South, Range 1 East of the Willamette Meridian. Beginning at an iron pipe on the southwesterly line side of River Road, which iron pipe is South 66 degrees 52 minutes West 863.8 feet distant from a point which is 751.10 feet South and 201.30 feet East of the quarter section corner between Sections 12 and 13, Township 2 South, Range 1 East of the Willamette Meridian, running thence North 51 degrees 59 minutes West 364.70 feet along the southwesterly side of said River Road to an iron pipe, thence South 66 degrees 35 minutes West 857.05 feet to an iron pipe, thence South 23 degrees 25 minutes East 59.09 feet to an iron pipe, thence South 52 degrees 41 minutes East 76.35 feet to an iron pipe, thence on a curve with a radius of 43.77 feet on a 60 degree 27 minute curve to the left 46.18 feet to an iron pipe, thence North 66 degrees 52 minutes East 704.25 feet to an iron pipe, thence North 62 degrees 24 minutes East 154.55 feet to an iron pipe on the Southwesterly side of River Road, thence South 51 degrees 59 minutes East 34.25 feet to an iron pipe, thence South 62 degrees 51 minutes West 170.9 feet to an iron pipe, thence South 66 degrees 52 minutes West 655.60 feet to an iron pipe, thence on a curve to the left having a radius of 10 feet through a circular angle of 90 degrees 17 minutes, a distance of 15.76 feet to an iron pipe, thence South 23 degrees 25 minutes East 45.62 feet to an iron pipe, thence South 37 degrees 40 minutes East 398.70 feet to an iron pipe, thence North 57 degrees 21 minutes West 165 feet, thence North 37 degrees 40 minutes West 143.36 feet to an iron pipe, thence North 62 degrees 16 minutes East 20.08 feet to an iron pipe, thence North 37 degrees 40 minutes East 141.63 feet to an iron pipe, thence North 66 degrees 52 minutes East 706.46 feet to an iron pipe and the point of beginning.



The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.*
