CERTIFICATE OF WATER RIGHT

This Is to Certify, That EMSLEY W. ROGERS

of Rt. 1, Dufur, State of Oregon, 97021, has
a right to the use of the waters of Ramsey Creeka tributary of Fifteen Mile Creek for the purpose of
the irrigation of 20.53 acresand that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Wasco County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 7, at page 406; that the priority of the
right thereby confirmed dates from 1897that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed one-eightieth and
three acre feet per acre in any irrigation seasonThe point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 2, NE $\frac{1}{4}$ SE $\frac{1}{4}$ & NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section
3, T. 25 S., R. 12 E., W. M., 2000 feet North and 600 feet East, 1870 feet
North and 760 feet West; 1300 feet North and 1750 feet West, all from the SE
Corner, Section 3A description of the place of use under the right, and to which such right is appurtenant, is as
follows:8.20 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 20.20 acre SE $\frac{1}{4}$ SW $\frac{1}{4}$ 7.50 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$ 2.40 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$ 2.23 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$



supersedes certificate of water right recorded on page 5663, Volume 6, State
Records of Water Right Certificates.The issuance of this superseding certificate does not confirm the status of the
water right in reference to ORS 540.610.And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
