of Cottage Grove Feed Store, Cottage Grove , State of Oregon, 97424 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Turner Creek and an unnamed spring

a tributary of North Yamhill River for the purpose of the irrigation of 15.0 acres, domestic use for one family and stock

under Permit No. 16935 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 4, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.21 cubic foot per second, being 0.19 c.f.s. from Turner Creek for irrigation and 0.02 c.f.s. from unnamed spring for domestic and stock purposes.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW_4 NE $_4$, as projected within Dodson DLC 41, Section 23, NW_4 SE $_4$, Section 22, T. 2 S., R. 5 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
