## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

FLORENCE L. MUELLER

of Rt. 3, Box 268, Oregon City , State of Oregon, 97045 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of an unnamed creek and reservoir constructed under Permit No. R-1565

a tributary of Parrot Creek for the purpose of irrigation of 3.0 acres and supplemental irrigation of 40.2 acres

under Permit No. 22630 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 28, 1953 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second from direct flow and storage on lands described as

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (NW $_4$  SW $_4$ ), Section 28, T. 3 S., R. 2 E., W. M., 250 feet South and 30 feet East from the W $_4$  Corner, Section 28

primary and 7.7 acre feet stored water only on lands described as supplemental.

The amount of water used for irrigation, together with the amoun secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1565.

conform to such reasonable rotation system as may be ordered by the proper state officer.
