CERTIFICATE OF WATER RIGHT

of Rt. 2, Box 54, Molalla , State of Oregon, 97038 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Molalla River

a tributary of Willamette River irrigation of 12.0 acres

for the purpose of

under Permit No. 20667 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 21. 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{2}$ NE $\frac{1}{2}$, as projected within C. Sweigle DLC 53, Section 15, T. 5 S., R. 2 E., W. M., 640 feet South and 370 feet West from the NE Corner, Section 15

The amount of water used for irrigation, together with the umount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Beginning at the most northerly northwest corner of the Charles Swegle DLC 53 in Section 10, Township 5 South, Range 2 East of the W.M., thence South 89 degrees 30 minutes West along the northerly line of that tract of land conveyed to Charles Swegle, by deed recorded January 22, 1856 in book "B" at page 201, Clackamas County records, 5.45 chains, more or less, to Market Road No. 32; thence South 51 degrees 30 minutes West along said road 24.25 chains, more or less, to the south line of the Mathias Swegle DLC 45, thence South 18 degrees 30 minutes West along the west line of the Charles Swegle DLC 53 a distance of 27.05 chains, more or less, to the southwest corner of said Charles Swegle DLC thence North 88 degrees East along the south line of said Charles Swegle DLC to the southwest corner of the plat of Shady Dell in Plat Book 18 at page 14, replatted as Replat of Shady Dell in Plat book 22 at page 1, records of Clackamas County, Oregon; thence northerly along the west line of said plat of Replat of Shady Dell to the north line of the Charles Swegle DLC 53; thence South 88 degrees 15 minutes West on claim line to the place of beginning.

This certificate is issued to supersede certificate of water right recorded on page 20554, Volume 15, State Record of Water Right Certificates so as to correct the date of priority.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes afore id is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
