a tributary of Willamette River irrigation of 25.6 acres

for the purpose of

under Permit No. 22163 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 2, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.32 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (SE $\frac{1}{4}$ SW $\frac{1}{4}$), and SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Minier DLC 60, Section 24, T. 4 S., R. 1 W., W. M., No. 1-270 feet South and 250 feet West, No. 2-910 feet North and 1270 feet West, both from the NE Corner of Minier DLC 60

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is part of that described as follows: Description of property recorded in Book 430, Page 243, Deed Records, Clackamas County, Oregon: All that portion of the Wm. Harris DLC in Section 24, Township 4 South, Range 1 West W.M. lying East of the meander line of Pudding River and South of the extended North line of the following described property, to-wit: The S^1_{2} of the SE^1_{3} of Section 24, Township 4 South, Range 1 West, W.M., except a strip 50 rods wide along the South side thereof and also that portion of the A. T. Minier DLC in Township 4 South, Range 1 West, W.M., described as: Beginning at the NE Corner of said Minier DLC, thence South on the East boundary of said DLC to the meander line of the Pudding River; thence Westerly and Northerly tracing the meander line of the Pudding River to a point of intersection with the North line of said DLC; thence East on said North line to the place of beginning.

This certificate is issued to supersede certificate of water right recorded on page 23097, Volume 16, State Record of Water Right Certificates so as to correctly describe the place of use.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
