CERTIFICATE OF WATER RIGHT

This Is to Certify, That PAUL C. LEE

of Box 1, Applegate, State of Oregon, 97530, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Humbug Creek

a tributary of Big Applegate River for the purpose of irrigation of 33.0 acres

under Permit No. 22380 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 29, 1953 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.41 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NW 1/4, Section 14, and NW 1/4 NW 1/4, Section 23, T. 38 S., R. 4 W., W. M., 900 feet North and 110 feet West from the Center, Section 14, and 570 feet South and 700 feet East from the NW Corner, Section 23

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 4.8 acres SW 1/4 SW 1/4 14.1 acres NW 1/4 NW 1/4
- 3.0 acres SE 1/4 SW 1/4 11.1 acres NE 1/4 NW 1/4

Section 14 Section 23 T. 38 S., R. 4 W., W. M. T. 38 S., R. 4 W., W. M.

Land on which water is to be used is a part of that described as follows: The South 1/2 of the SW 1/4, Section 14; and the NE 1/4 NW 1/4, and Government Lot 1 of Section 23, all in Township 38 South, Range 4 West, W.M., in Jackson County, Oregon.

This certificate is issued to supersede certificate of water right recorded on page 21633, Volume 16, State Record of Water Right Certificates so as to correctly locate the point of diversion. The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
