CERTIFICATE OF WATER RIGHT

This Is to Certify, That

B. E. CARSON

of Jet , State of Oklahoma, 73749 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Snake River

a tributary of Columbia River irrigation of 28.5 acres

for the purpose of

under Permit No. 19925 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 7, 1950 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.71 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 9 (SE4 SE4), Section 15, T. 18 S., R. 47 E., W. M., 650 feet North and 650 feet West from the SE Corner, Section 15

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

19.3 acres Lot 1 (SW4 SW4) Section 14

9.2 acres Lot 9 (SE¼ SE¼) Section 15 T. 18 S., R., 47 E., W. M.

Land on which water is to be used is part of that described as follows: That portion of Morton Island being in Lot 1, Section 14, and Lot 9, Section 15, all in Township 18 South, Range 47 East, W.M., described as follows: Beginning at a point 3.55 chains North 14 degrees 34 minutes West from the Meander Corner to Sections 14 and 23, Township 18 South, Range 47 East, W. M.; thence South 88 degrees 42 minutes West 33.2 chains thence North 1 degree 11 minutes West to the Meander Line; thence easterly along said Meander line to the place of beginning, containing 28.93 acres, more or less. All being in Malheur County, Oregon.

This certificate is issued to supersede certificate of water right recorded on page 21934, Volume 16, State Record of Water Right Certificates, so as to correctly describe the location of the point of diversion and place of use.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
