CERTIFICATE OF WATER RIGHT

This Is to Certify, That 12 H, INC.

of Rt. 1, Athena, State of Oregon, 97813, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells

a tributary of Butter Creek for the purpose of irrigation of 136.8 acres

under Permit No. G-3197 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 16, 1966 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.71 cubic feet per second, being 0.49 c.f.s. from No. 1 and 1.22 c.f.s. from No. 2

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{2}$ NE $\frac{1}{2}$, SW $\frac{1}{2}$ SE $\frac{1}{2}$, Section 28, T. 4 N., R. 27 E., W. M., No. 1-3180 feet North and 1470 feet West; No. 2-20 feet North and 1350 feet West, both from the SE Corner, Section 28

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

 22.0 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
 8.4 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$

 40.0 acres SW $\frac{1}{2}$ SE $\frac{1}{2}$
 40.0 acres SE $\frac{1}{2}$ SE $\frac{1}{2}$

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
