CERTIFICATE OF WATER RIGHT

This Is to Certify, That

J. H. CROCKER

of Rt. 1, Cornelius , State of Oregon, 97113 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of East Dairy Creek

a tributary of Tualatin River irrigation of 62.6 acres

for the purpose of

under Permit No. 20601 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 19, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE¼ NE¼ SE½, NW½ SE½, all as projected within Harmes DLC 40, Section 34, T. 2 N., R. 3 W., W. M., No. 1-80 feet North and 850 feet West; No. 2-80 feet South and 1240 feet West; No. 3-720 feet South and 2060 feet West, all from the E^1_4 Corner, Section 34

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
