## CERTIFICATE OF WATER RIGHT

of Rt. 1, Box 152, Newberg , State of Oregon, 97132 proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of unnamed stream and reservoir constructed under Permit No. R-1375

a tributary of Chehalem Creek irrigation of 15.6 acres

for the purpose of

under Permit No. 21244 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 18, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 NW4, as projected within Grave! DLC 45, Section 7, T. 3 S., R. 2 W., W. M., 1500 feet South and 370 feet East from the NW Corner, Section 7

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1375.

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.9 acres NE4 NW4

2.0 acres NW4 NW4

3.0 acres SW4 NW4

6.7 acres SE $\frac{1}{2}$  NW $\frac{1}{4}$  All as projected within Gravel DLC 45 Section 7

T. 3 S., R. 2 W., W. M.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.
